

## **GUIDELINES: 2019 Mid Atlantic Conference (MAC) Men's and Women's Sevens**

### **Section 1. Qualification Tournaments.**

#### **1. Men's/Women's Qualifiers:**

The 2019 MAC Sevens Season will consist of 3 Qualifier Tournaments for the Men's Premier Division (MP)/Men's Open Division (MO), and 3 Qualifier Tournaments for the Women's Premier Division (WP).

The final qualifier tournament will act as a qualifier for the Men's Premier, and Women's Premier division equally weighted as the previous 2 qualifiers. Hence, the last qualifier holds no greater weight than the previous 2 qualifiers for MP and WP. **The 1 team from the MP and 3 teams WP representing the MAC in the Nationals Men's Club 7's will be decided by point accumulation at the 3 qualifiers** (see section 10 for tie-breaker scenarios).

The MAC Men only has 1 bid to National Club 7's Championship in 2019. There is an opportunity for 2 teams from MAC to win a bid to the National Club 7's Championship and is detailed in section 10.2.

The final qualifier tournament will act as a winner take all tournament for the **Men's Open Division only**. Teams will accumulate points in the previous 2 qualifiers to determine qualification and seeding.

Qualifiers begin in June and the last qualifier will be held in July for both divisions.

##### 1.1. Qualifier Tournament Venues

- June 22 – Baltimore-Chesapeake RFC
- July 13–Wilmington RFC
- July 20 – NOVA RFC

### **Section 2. Qualifier Divisions.**

#### **2. Divisions:**

Any team may enter MAC qualification tournaments regardless of the region with which they are associated; however teams must meet below requirements to uphold the intent of the qualification process. Further, MAC Points will only be awarded to the MAC clubs striving to participate in the National Club 7s Championships, or win the Men's Open Division.

2.1. **Men's Premier** - A division available to any CIPP registered club, MAC or non-MAC. Points will only be awarded to MAC Teams and who have also declared their "intent to participate (see section 3.1)" in qualification for National Men's Club 7's

2.1.1. Non-MAC teams must be a CIPP registered club, and all players participating in the tournament must be CIPP registered for said club. Non-MAC team's entrance is at the discretion of the MAC 7's board.

2.1.2. A MAC team can field "development sides" without CIPP registering a separate club, as long said club has declared "intent to participate." Developmental teams entrance is at the discretion of the MAC 7's board

2.2. **Men's Open** - A division available to any CIPP registered club, MAC or non-MAC. Points will only be awarded to MAC Teams and who have also declared their "intent to participate (see section 3.2))" in the Men's Open Division.

2.2.1. Non-MAC teams need to be a CIPP registered club. Members don't have to be CIPP registered for said club, but must be CIPP registered with a club.

- 2.3. **Women's Premier** - A division available to any CIPP registered club, MAC or non-MAC. Points will only be awarded to MAC Teams and who have also declared their "intent to participate (see section 3)" in qualification for National Men's Club 7's
  - 2.3.1. Non-MAC teams must be a CIPP registered club, and all players participating in the tournament must be CIPP registered for said club
  - 2.3.2. A MAC team can field multiple sides without CIPP registering a separate club, as long said club has declared "intent to participate."

### Section 3. Intent to Participate

#### 3. Intent to Participate:

A club's "intent to participate" is simply notifying MAC 7's Committee and Tournament organizers of your club's aspirations by participating in Qualification Tournament. This process allows the MAC 7's Committee to provide the highest level of 7's by not being inclusive, and further does not diminish from the intent of the qualification process. **The "intent to participate" must be made by Tuesday at 10:00 p.m. the week of Qualifying Tournament.**

3.1 **Men's Premier** - Any club wishing to participate in the Men's Premier Division at a MAC qualifier must notify MAC 7's committee indicating themselves as one of the following: Qualifier, Developmental, or Non-MAC.

**Please note deposit required for teams declaring themselves "Qualifier."**

- 3.1.1. **Qualifier** – A CIPP registered club within the MAC that is attempting to qualify for the National Club 7s Championships.
  - 3.1.1.1. **Any Club who declares "Qualifier" as their intent is subject to pay a \$250 deposit to their local union before their first entered qualifier tournament. If said club shows up to at least 2 qualifier tournaments one of which must be the FINAL Qualifier, July 20, the deposit is refunded at the last qualifier tournament.**
    - 3.1.1.1.1. **EPRU:** Checks sent to Frank Lentz made out to Eastern Pennsylvania Rugby Union- 712 Bower Rd., Shermans Dale, Pa 17090
    - 3.1.1.1.2. **Capital:** Checks sent to Dave Chapman made out to Capital Rugby Union – 1134 Magnolia Ave., Norfolk VA 23508
    - 3.1.1.1.3. In the event a club does not participate in 2 Qualifying Tournaments in the Premier Division, the deposit will be forfeited and distributed to those teams qualifying for National Club 7's Championship.
  - 3.1.1.2. **Developmental** – A CIPP registered club within the MAC fielding multiple sides not attempting to qualify it's lower side(s) for National Club 7's Championship.
    - 3.1.1.2.1. Developmental sides are not subject to a deposit and can move between Premier and Open Divisions based on discretion
  - 3.1.1.3. **Non-MAC** – A CIPP registered club not within the MAC
    - 3.1.1.3.1. Non-MAC sides are not subject to a deposit
- 3.2. **Men's Open** - Any club wishing to participate in the Men's Open Division at a MAC qualifier must notify MAC 7's committee indicating themselves as one of the following: Open, Social, or Non-MAC
  - 3.2.1. **Open** - A CIPP registered club within the MAC that is attempting to win the Men's Open Division Championship.
  - 3.2.2. **Social** – A team, or club within or not within in the MAC **not** attempting to win Men's Open Division Championship.
- 3.3. **Women's Premier** - Any club wishing to participate in the Women's Premier Division at a MAC qualifier must notify MAC 7's committee indicating themselves as one of the following: Qualifier, Developmental, or Non-MAC. **Please note deposit required for teams declaring themselves "Qualifier."**
  - 3.3.1. **Qualifier** – A CIPP registered club within the MAC that is attempting to qualify for the National Club 7s Championships.
    - 3.3.1.1. **Any Club who declares "Qualifier" as their intent is subject to pay a \$250 deposit to their local union before their first entered qualifier tournament. If said club shows up to at**

**least two qualifier tournaments, one of which must be the last qualifier held on July 20, the deposit is refunded at the last qualifier tournament.**

3.3.1.1.1. **EPRU:** Checks sent to Frank Lentz made out to Eastern Pennsylvania Rugby Union- 712 Bower Rd., Shermans Dale, Pa 17090

3.3.1.1.2. **Capital:** Checks sent to Dave Chapman made out to Capital Rugby Union – 1134 Magnolia Ave., Norfolk VA 23508

3.3.1.1.3. In the event a club does not participate in 2 Qualifying Tournaments in the Premier Division, the deposit will be forfeited and distributed to those teams qualifying for National Club 7's Championship.

3.3.2. **Developmental** – A CIPP registered club within the MAC fielding multiple sides not attempting to qualify its lower side(s) for National Club 7's Championship.

3.3.2.1. Developmental sides are not subject to a deposit and can move between Premier and Open Divisions based on discretion

3.3.3. **Non-MAC** – A CIPP registered club not within the MAC

3.3.3.1. Non-MAC sides are not subject to a deposit

#### **Section 4. Club Eligibility.**

##### **4. Club Eligibility:**

MAC follows the eligibility regulations of USA Rugby. The following are taken directly from USA Rugby's Eligibility Regulations for National Men's Club Sevens Championships. A newly formed club that plays sevens exclusively will need to register as any other club would. **June 15th, 2019** is the registration deadline for 7s season.

4.1 Players may form and join any sevens club, regardless of their fifteens affiliation.

4.2 A club may be registered solely to play sevens

4.3 Players may transfer from a fifteens club to a sevens club and transfers can be denied by their club for outstanding financial issues or disciplinary matters with their Territorial Union (TU) or Local Area Union (LAU)

4.4 Players may transfer from a fifteens club to a sevens club and transfers can be denied by their club for outstanding financial issues or disciplinary matters with their Territorial Union (TU) or Local Area Union (LAU)

4.5 For the USA Rugby Men's and Women's Club Sevens Championships, at least 9 players on the roster must meet National Team eligibility standards

4.6 Players may register with any sevens club, but may not play in any qualifying tournaments for any other club during a USA Rugby qualifying match

#### **Section 5. Player Eligibility.**

##### **5. Player Eligibility:**

The purpose of these regulations is to prevent club hopping and the importation of guest players late in the season to strengthen teams for qualification into the National Club 7's Championship and ensure teams competing at the Championship event are reflective of the team that qualified.

5.1. Play in at least two sevens matches at least a week apart from each other prior to this USA Rugby Championship Event for the club. These tournaments must be USA Sanctioned tournaments which all 3 Qualifiers, and the US Rugby Eastern Open Qualifier are both men's and women. **Subsequent to this rule, a player must play in at least one sevens qualifier or other sevens matches prior to the final MAC qualifier.**

5.1.1. In the event a player has not played in one sevens qualifier or other sevens match prior to the final MAC qualifier, said player will be ineligible to play in the final MAC qualifier

5.1.1.1. A player must provide proof (submitted rosters, photos, video, etc.) if seeking qualification via non-qualifying tournaments and is at the discretion of the 7's committee to prove if valid.

- 5.1.1.2. A player having not played in one sevens qualifier or other sevens match prior to the MAC finals can seek a waiver from USA Rugby seeking to waive the match requirement clause thus making them eligible for the Club National Championship. If waiver from USA Rugby is approved prior to the MAC Finals said player will be eligible for MAC finals. Waiver must be approved, pending will not suffice
- 5.1.1.3. In the event a player has not played in at least one sevens qualifier or other sevens matches prior to the final MAC qualifier, nor has received a waiver form USA Rugby prior to the MAC Finals, that does not prohibit them from playing at Club Nationals. The player would need to submit a waiver to USA Rugby waiving the match requirement and potentially still become eligible for Club Nationals.
- 5.2. Be CIPP enrolled for the club, through initial enrollment or transfer, prior to the earlier of (i) playing in any match pursuant to a) above and (ii) July 1.
- 5.3. Have not played in any qualifying tournaments (unless outside the qualifying division) for any other club.
- 5.4. Player must be at least 18 years of age, unless granted a waiver by USA Rugby Eligibility Committee. Enforcement of USA Rugby laws is the responsibility of the MAC Sevens Committee members. Absent a complaint, checking of passports is at their discretion. However, in the event of a complaint the MAC Sevens Committee must take the lead on clarifying eligibility. In the event a team is found to have used an ineligible player, at a minimum they will forfeit ALL points earned on that day.

## **Section 6. Roster Management.**

### **6. Roster Management:**

The purpose of these regulations is to ensure all teams are meeting USA Rugby eligibility requirements. This not only to benefit the MAC 7's Committee in ensuring teams/players are eligible, but also a benefit to the participating clubs ensuring them all players would be eligible if to reach the National Club 7s Championship.

- 6.1. Teams in the MP, MO, and WP divisions are required to complete and **email the Excel Roster Form located on the MAC website by 5:00PM Thursday prior to each of the tournaments** in which the team is participating. The roster form is to be emailed to all of the Sevens Committee's representatives listed at the beginning of this document
  - 6.1.1. It is not necessary to indicate exactly who is actually playing for each team until the day of the tournament when the team checks-in
  - 6.1.2. ***For each qualifier, should only add names to the previously submitted roster forms.***
- 6.2. All MAC MP and WP players CIPP registrations and transfers must show up on the club CIPP list from USA Rugby dated no later than the Friday immediately prior to the tournament. Failure to provide proof by 6:00PM on the Monday following the tournament that the CIPP and/or transfer process was completed by the required Friday deadline will result in a delay of the awarding of points. Teams playing ineligible players forfeit all points earned in the tournament and face possible additional sanctions.)
- 6.3. All MAC MP and WP team's must adhere to regulations listed in "**Section 5 Player Eligibility**"
- 6.4. **Teams fielding Multiple sides in Premier Division (MP or WP)**
  - 6.4.1. **Multiple "Qualifier" teams as indicated in "intent to participate" (see section 3)** – Teams must have separate clubs registered with USA Rugby
    - 6.4.1.1. Player swapping is forbidden both the day of the tournament and subsequent tournaments for the totality of the summer, even if one of your teams decides to no longer play in the "Qualifier" Division as this would fall under regulation 5.3 as playing for another club.
    - 6.4.1.2. **"Qualifier" and "Developmental" as indicated in "intent to participate"** – Teams can play under one CIPP registered club with USA Rugby
      - 6.4.1.2.1. Player swapping is forbidden the day of the tournament, but a player can move to another one of the club's sides in subsequent weeks.
- 6.5. **"Non-MAC" teams in Premier Division (MP or WP)**
  - 6.5.1. All players must be CIPP registered for the participating club
- 6.6. **Men's Open**
  - 6.6.1. Players must be CIPP registered the day of the tournament, but do not have to be CIPP registered with club competing for that day

- 6.6.1.1. **Please note that if a player is not CIPP registered with your club and plays in the Open Division that does not count as “play in at least two sevens matches at least a week apart from each other prior to this USA Rugby Championship Event” as discussed in Section 5 since, they were technically not a member of your club.**
- 6.6.1.2. Once a player has played for your club in Men’s Open, he is not allowed to participate with any other Men’s Open teams
- 6.6.1.3. Please note to play in MP or WP, a player must be adhere to Section 6.2 even if they have played for your club in Men’s Open and may not have been on that roster for weekend they participated.
- 6.7. **Roster Swapping – Any** swapping of players between sides (regardless of Division) on tournament day will result in forfeit of all points earned that day by both offending teams.

### **Section 7. Tournament Guidelines.**

#### **7. Tournament Guidelines:**

The purpose of these regulations are to make sure all events are uniform, and setting a standard for both teams and host to abide by

##### **7.1. Tournament Seedings:**

- 7.1.1. The Tournament Director will email a list of the teams that have registered in each division for the upcoming qualifier tournament to the Sevens Committee’s representatives listed at the beginning of this document soon after the TUESDAY, 10:00PM DEADLINE
- 7.1.2. The first **2019** Qualifier will be seeded by **2018** results according to:
  - 7.1.2.1. Finish at Nationals
  - 7.1.2.2. Final 2018 MAC Standings
  - 7.1.2.3. Tie-Breakers will be decided by MAC 7’s Committee
- 7.1.3. Subsequent qualifiers will be seeded by the results of the previous qualifiers as follows:
  - 7.1.3.1. Total Points
  - 7.1.3.2. Qualifiers won
  - 7.1.3.3. Total wins
  - 7.1.3.4. Delta Points
  - 7.1.3.5. Coin Flip

##### **7.2. No Show Seedings/Forfeit Points:**

- 7.2.1. In the event a team does not show up, the MAC 7’s committee and tournament director will work to develop alternative brackets if possible.
  - 7.2.1.1. If re-bracketing is not possible, the event will be reseeded so that the no show team is placed last in the pool and their forfeit should count as a 28-0 loss

##### **7.3. Kick off times:**

- 7.3.1. The MP and WP Division will kick-off no earlier than 10:00AM. The QO Division can kick-off earlier or later according to the desires/resources of the Tournament Director.
  - 7.3.1.1. All MP and WP should be prepared to play at 10:00AM although kick-off can be later.  
***Tournament Director/MAC committee can alter tournament schedule up to 5:00 PM Friday before the tournament, therefore all teams should be prepared and plan travel accordingly to play at 10:00 AM***

##### **7.4. Scheduling of games:**

- 7.4.1. MP and WP games should be at least 1 hr. and 20 minutes hours from start of preceding match to kickoff of the subsequent match.
- 7.4.2. MP and WP should not exceed 3 hours from start of preceding march to kickoff of the subsequent match.
- 7.4.3. Above requirements should be achievable as detailed in your bids for hosting. If the amount of Men’s Open or Social games causes the above schedule to not be possible, you must adjust the amount of social and open teams.
- 7.4.4. **All schedules must be approved by MAC 7’s Committee**

##### **7.5. Tournament Format:**

- 7.5.1. The format for pool play and play-offs will be determined per qualifier tournament dependent upon the number of teams registered within each division. Tournament Directors will work with the MAC Sevens Committee members to determine the best possible options of play
- 7.5.2. Pool advancement, for those that have semi/quarter finals is determined by:
- 7.5.2.1. Record in pool
  - 7.5.2.2. Total wins
  - 7.5.2.3. Head-to-head-competition
  - 7.5.2.4. Point differential
  - 7.5.2.5. Tries scored
  - 7.5.2.6. Converted tries scored
- 7.5.3. Third place in Championship bracket matches are to be scheduled. If one team decides not to play, the 3rd place points will be awarded to the team willing to play and the 4th place points to the conceding team. If both teams concede, each team will receive the points allocated to the fourth place team.
- 7.5.3.1. 5/6<sup>th</sup> place match, 7/8<sup>th</sup> place matches, etc. are to be scheduled. If one team decides not to play, the higher points will be awarded to the team willing to play and the lower place points to the conceding team. If both teams concede, each team will receive the points allocated to the lower finish (i.e. in 5/6<sup>th</sup> place game, both teams would get the 6th places points (12)).
- 7.5.4. Championship and 3rd place Ties will be resolved according to the 'Standard Set of Variations Appropriate for the Seven-a-Side Game' in the current Law Book.
- 7.5.5. In the event of any post-match discrepancy or disciplinary actions, those teams who originally placed below the disciplined team will move up accordingly in receiving points.
- 7.5.6. Seeding: Points will be awarded in the following manner for the following places in a Qualifying Tournament:
- 7.5.6.1. **First place – 22 points**
  - 7.5.6.2. **Second Place – 19 points**
  - 7.5.6.3. **Third Place – 17 points**
  - 7.5.6.4. **Fourth Place – 15 points**
  - 7.5.6.5. **Fifth Place – 13 points**
  - 7.5.6.6. **Sixth Place – 12 points**
  - 7.5.6.7. **Seventh Place – 10 points**
  - 7.5.6.8. **Eight Place – 9 points**
  - 7.5.6.9. **Ninth Place – 8 points**
  - 7.5.6.10. **Tenth Place – 7 points**
  - 7.5.6.11. **Eleventh Place - 5 points**
  - 7.5.6.12. **Twelfth Place - 3 points**
  - 7.5.6.13. **If more than twelves teams, teams finishing 13 or greater are given 1 point.**
- 7.5.7. **Tournament Cancellation:** If one tournament needs to be cancelled or end early due to adverse weather conditions, point totals stay as they are at the time of cancellation.

## **Section 8. Tournament Registration.**

### **8. Qualifier Tournament Registration:**

The purpose of this section is to make sure MAC qualifiers are inclusive of all teams wanting to participate in qualifying for the National Club 7s Championships, but also allowing enough time for organizers to run a class event.

#### **8.1. Qualifier Tournament Registration –**

- 8.1.1. Teams participating in the QP, QO, and WP must register by **10:00PM on the Tuesday prior to the tournament for guaranteed entry**
- 8.1.2. Entry to the qualifier tournament after the deadline for MAC MP and WP teams is at the discretion of the MAC 7's Committee for the event.
- 8.1.3. Teams competing in the MP, WP, and MO take precedent over all other teams entering the tournament before the Tuesday deadline.

- 8.1.3.1. Men's Open teams competing as social may need to be dropped due to this and it is at the discretion of the MAC 7's Committee in conjunction with the Tournament Director should this happen.
  - 8.1.4. Entrant registration method must include acceptance of an emailed letter of commitment ONLY by the Tournament Director.
  - 8.1.5. MAC will hold any team liable to a fine and the full entry fee (for each team entered) for backing out of a tournament after the above deadline if a Tournament Director is holding a faxed or emailed commitment. For example: Widget RFC confirms that Widget I and Widget II will attend a qualifier, but backs out after Tuesday at 10:00 p.m. EDT; each side owes the full entrance fee and can be fined by their local union. This holds true if a team registers after the deadline, is accepted into the tournament and then backs out prior to or on the day of the event.
- 8.2. **Tournament Registration Fees:** Tournament hosts cannot charge Eligible MAC teams more than the fixed rate of \$250.00. Tournament hosts may charge non-MAC teams or teams not Eligible any rate they choose. **All tournaments, including the last qualifier have a registration fee.**

### **Section 9. Qualifier Tournament Hosts.**

#### **9. Tournament Host requirements:**

The purpose of this section is to ensure MAC qualifiers are held to a certain standard reflective of a National Qualifying event.

- 9.1 **Tournament Director** - Designate a single individual to be a Tournament Director (TD) whose responsibilities include managing brackets, ensuring timely kick-offs, securing and briefing referees
- 9.2 **Referee Assignments** – MP and WP must be assigned to MARR referees. The TD should contact the MARR RDO to facilitate this. MARR will ask for local referee society support as needed to cover the MP and WP. The TD should contact the local referee society for assigning all other games
- 9.2.1 **MARR RDO** – Mike O'Brien – mikeob9@gmail.com
- 9.3 **Water/Fluids** - Provide for access to water/fluids either free or available from a vendor at the field, or within 0.25 mile from the tournament facility.
- 9.4 **Balls** – *Each field should have 2 match balls at all times, one in play and one at mid field. The TD should monitor this throughout the day to ensure this is consistent for all matches*
- 9.5 **Scheduling games** – Please note section 7.4
- 9.6 Tournament organizers must submit win/loss records and scores for all teams entering qualifying divisions by e-mail on the Monday following the tournament to the Sevens Committees members listed at the top of this document.

### **. Section 10. Advancement to National Men's/Women's Club Sevens Championships.**

#### **10. Advancement to National Men's/Women's Club Sevens Championships**

As Stated in section 1, teams in the Men's Qualifier Premier Division and Women's Qualifying Premier Divisions vying to represent the MAC at the National Men's Club Sevens Championships will be decided by total point accumulation from the 3 qualifiers. Likewise, **the third qualifier will act as a final qualifier and will carry the same weight as the previous 2 qualifiers.**

- 10.1 **Advancement** - In determining which clubs shall qualify for the USA National Club Sevens Championships, the following guidelines and tie breakers will be applied:
  - 10.1.1 Compliance with the minimum of attending three MAC Men's Premier Qualifiers (1 of 3 must be final MAC qualifier).
  - 10.1.2 Points awarded for eligible tournaments (All four MAC qualifiers)
  - 10.1.3 Qualifiers won
  - 10.1.4 Head to head (wins vs. losses in qualifiers)
  - 10.1.5 Head to head (delta points in qualifiers)
  - 10.1.6 Gross points scored in all appointed qualifiers
  - 10.1.7 Net points scored in all appointed qualifiers

**10.1.8** Winner of last head to head match

**10.2 USA Rugby Men's "Open Qualifier"** – The Men's MAC teams only have 1 bid to the National Club 7's Championship, but have an opportunity to earn a bid back at the "Open Qualifier" on 6/29 & 30//2019 (Malvern, Pa.)

**10.2.1 Winning "Open Qualifier"** – If any MAC team wins the "Open Qualifier" they automatically qualify for Nationals Club 7's Championship regardless of their standings at the end of the MAC 7's Qualifier Division thus the MAC would have 2 bids at National Club 7's.

**10.2.1.1** If winner of "Open Qualifier" finishes 1<sup>st</sup> in MAC Qualifier Series, the second place team from MAC would also go to National Club 7's Qualifier

**10.2.1.2** Only teams actively participating in the qualification process are eligible to enter the "Open" Qualifier per USA Rugby, thus if a MAC Team wins the "Open" Qualifier they must continue to adhere to MAC rules regarding qualifier attendance detailed in section 3.1 and 10.1.1

**10.2.2 Winning Bid for MAC but not automatically qualify** - In the event a Geographic Union which has 3 bids to National Club 7's (Northeast/Frontier) wins a USA Rugby "Open Qualifier", the next highest finisher from a GU that does not have 3 bids to Nationals would win a bid for their GU. That club **does not** qualify for Nationals, they simply win a bid for their GU.

**10.2.2.1** For example, If Old Blue wins a "Open Qualifier" they would qualify for Nationals, but the Northeast would not receive an additional bid to Nationals as Northeast has 3 bids in 2018. If Norfolk would finish runner-up, the MAC would receive a 2<sup>nd</sup> bid to Nationals, but Norfolk would not automatically qualify. Representatives would still be determined as described in section 10.1

## Section 11. Men's Open Championship

### 11. Men's Open Championship

As Stated in section 1, the final qualifier tournament will act as a winner take all tournament for the **Men's Open Division only**. The team receiving the most points in the three previous qualifiers will be seeded first at the MAC Championship tournament, the team with the second most points will be seeded second, etc.

**11.1 Qualifying for MAC Open Championship** - The MAC Men's Open Championship entrants will be determined by total number of points accrued at qualifiers. Qualifier winners will automatically secure a spot in the championships but will not be guaranteed a Top 2 Seed

**11.1.1 Qualifying** – Team must win one of previous 2 qualifiers, and/or accrue enough points to finish in the top 8 of men's open teams. Points will be awarded per section 7.

**11.1.1.1.1 More than 8 teams may qualify, but is at the discretion of the MAC 7's committee. A minimum of 8 will qualify**

**11.2 Intent to Participate in Championship** - If a team accrues enough points or a win that places them in the top 8 teams in the Men's Open Division; it is assumed that teams will fulfill their obligation to participate in the MAC Championships. **A team not intending or able to participate in the MAC Championships must inform the MAC Sevens Committee members of this decision by 5:00PM on Monday, July 15, 2019**, at the latest. Teams that cancel after that date or fail to show up will be subject to penalty by the MAC.

**\*\*\*Any MAC Policy contradictory to USA Rugby Policy, MAC officials have vetted through USA Rugby and had been approved. All enforcement of rules and regulations is up to MAC 7's Committee members. Any dispute with rules and regulations will be heard and decided upon by the MAC 7's Committee with guidance from USA Rugby. This applies to any issue that may have not been addressed above. \*\*\***
